This website does not collect personally identifiable information from your computer when you browse the site. This means that, unless you voluntarily and knowingly provide us with personally identifiable information, we will not know your name, your e-mail address, or any other personally identifiable information.

Internet Protocol (IP) Address

This website does not collect personally identifiable information from your computer when you browse the site. Cookies

Our website uses "cookie" technology. "Cookies" are strings of text that a website may store on a user's computer. Our website uses cookies but only requires them in the online reservation process. Cookies enable our website to keep track of your preferences and activities relating to the website. Our website creates session cookies for each visit in order to facilitate your visit. The session cookie expires at the end of the session.

Information We Collect

When we need to collect personally identifiable information from you, we will ask you to voluntarily supply us with the information we need. For example, if you would like more information on our services or join our newsletter, we will ask you for information such as name, company, phone, and e-mail address to create your account. We may use your e-mail address to send a confirmation and, if necessary, might use the other information to contact you concerning your relationship with Net2Vault. As indicated below (see E-Mail section), we may also use your e-mail address to notify you with updates in the world of social media and digital advertising.

E-Mail

It is our intent to only send you e-mail communication that will be useful to you and that you may want to receive. When you sign up for our free newsletter and provide your e-mail address, we will contact you via e-mail and provide about news we want to share with you. This is usually only up to 4(four) times per month. These communications will relate to Net2Vault and/or the promotions of select third parties with whom Net2Vault has a strategic marketing relationship because they offer products or services that we believe would of interest to you. We use a third party e-mail service provider to send e-mails. This service provider is prohibited from using your e-mail address for any purpose other than to send Net2Vault related e-mail. Every time you receive e-mail you will be provided the choice to opt-out of future e-mails by following the instructions provided in the e-mail, or you may opt-out by updating your online profile.

Use of Information

We treat the information you provide to us as confidential information; accordingly, it is subject to our company's security procedures and strict corporate policies regarding protection and use of confidential information. Because laws applicable to personal information vary by country, we may put in place additional measures that vary depending on the applicable legal requirements. Information collected on the sites covered by this privacy statement, which are listed in the first paragraph, is generally processed and stored in the United States.

The personally identifiable information you provide to us is made available to Net 2 Vault employees for the purpose of providing you information relative to our products and services and where necessary for internal quality assurance and related uses.

Net2Vault may use the services of a third party mail house for the sole purpose of mailing materials.
